
Things to look for:

- Patterns of behavior in your neighborhood that make you suspicious.
- Let common sense be your guide. Example: One strange car may simply be an out of town visitor, many brief stops may be a sign of suspicious activity.
- Some other common signs include:
 - Unusual late night traffic or activity.
 - Exchanges of money and packages from curbside to car window.
 - Car horn “signals.”
 - Sharing of substance among a group.

Some advice:

Do not attempt to confront any individuals that you suspect, no matter how insignificant it may seem (example: playing loud music from a vehicle parked in front of your house). In that case, when a situation must be immediately addressed, call 911.*
